# MINUTES OF THE REGULAR MEETING OF THE BOARD OF DIRECTORS

#### INDIAN HAMMOCK HUNT AND RIDING CLUB

June 14, 2015

The meeting was called to order by President Marion Aiello at 9:00am. All Directors were present either in person or on conference call.

Motion to approve the minutes of the May 17, 2015 regular board meeting made by Tyra Willis and second by Bill Miller. Motion passed.

**Treasurer's Report** - Corey Miller reported that we are \$3300.00 ahead of budget. Noting this has the special assessment dollars, which is in progress in this total.

Corey Miller made a motion to consolidate the staff leasing and associated taxes into one line item of staff leasing and Barbara Roberts seconded. Motion passed

Corey Miller made a motion and Matt Rector seconded to have a fundraiser or receive donations to purchase a TV and place it in the great room at the Lodge. Motion passed.

Motion made by Corey Miller and seconded by Tyra Willis to release \$3230 from special assessment funds and return to Operating Reserve Funds for work done at Skeet & Trap. Motion passed. Motion made by Corey Miller and seconded by Tyra Willis to release \$1088 from special assessment funds and return to Operating Reserve Funds for the work done at the Gate House. Motion passed.

Motion by Corey Miller and seconded by Barbara Roberts to spend \$2115.34 from the Operating Reserve Funds to place a 2" PVC schedule 40 pipe from the well at the lawn bowling green to the pool. Motion passed.

Motion made by Corey Miller and seconded by Tyra Willis to spend \$5813 from the asset reserve fund to purchase a microwave (\$275), refrigerator (\$4715.17) and freezer (\$822.83) to replace those items in the kitchen. Motion passed.

Motion made by Corey Miller and seconded by Barbara Roberts to accept the bid from Smalls Electric for \$2472 for the feed barn. Motion passed. Motion made by Corey Miller and seconded by Barbara Roberts too accept the bid from Smalls Electric for \$3122 for the cottage. Motion passed. Note both bids are within the approved cost of the work to be done on the special assessment.

Motion made by Matt Rector and seconded by Corey Miller to allow our Manager to spend up to \$500.00 to place a 2" PVC schedule 40 pipe to the Lodge when the other PVC pipe is place to the pool. Motion passed.

Motion to approve the design of the pump house by Corey Miller and seconded by Matt Rector. Motion passed with Doug Donohue opposed.

Motion made by Barbara Roberts and seconded by Corey Miller to put single pane windows at the Fitness Center when the front of the building siding is replaced. Motion passed.

Motion made by Matt Rector and seconded by Jason Bessenbacher to have stain used on the new 5 Stand building. Motion Passed.

Motion made by Corey Miller and seconded by Doug Donohue to have an electronic directory and put it on the secured part of Indian Hammock Web Site. Motion passed.

Motion made by Barbara Roberts and seconded by Corey Miller to approve the pole barn for Lot 22. Motion made by Corey Miller and seconded by Matt Rector to call the question. Motion passed. Motion made by Doug Donohue and seconded by Carla Sapp to approve the new hunt areas. After much discussion motion to table by Bill Miller and seconded by Corey Miller until notification to the membership and future studies of the areas. Motion passed with Jason Bessenbacher, Matt Rector, Carla Sapp and Doug Donohue opposed.

Motion made by Doug Donohue and seconded by Tyra Willis to remove from the agenda the item of not having a Board meeting in July. Motion passed.

# **MANAGER'S REPORT**

TO: Board of Directors, Indian Hammock Hunt & Riding Club, Inc.

SUBJECT: Monthly Report May – June 14, 2015

**Lodge:** A draftsman has prepared a draft for the lodge pump house roofing re-design for board approval.

**Meals**: This past month the lodge served 218 lunches, 82 dinners, 25 desserts, and 7 kids.

# Land & Building Maintenance:

The Hammock was reimbursed for damages to the front gate in the amount of \$

1,078. This covered our labor and equipment for repairs.

\$711.50 was collected in burn pile fees for the cleaning of 2 lots.

(31) 6x16' 5 quarter boards were purchased for \$12 a board for a savings of \$5.50 a board. To be used for stable repairs.

Grazon Next HL: Has been effective for stinging nettle in the horse pastures. It is also good for broad leaf weeds.

**Roads**: Re-surface completed from the gate to the flag pole.

**Pool**: Further testing of the lawn bowling water shows good results for PH hardness and phosphates. The cost to trench from the Lawn Bowling over to the pool and place a 2" schedule 40 PVC line is \$2115.34 . I recommend that if this water is tied to the pool to use it for the summer and monitor for phosphates and chemical use. Due to the extreme readings of phosphates we are using twice the chlorine to try and control the black algae. After monitoring of a minimum of two months consider refurbishing the pool.

# **Special assessment project updates:**

**Skeet & Trap**: The budget for this project is \$3,230, we have already spent \$3,214.11 on materials, with \$15.89 remaining in the budget. And a total of 258.5 man hours worked.

#### **Birds Nest:**

**Bench**: The budget for this project is \$175.00, with \$31.93 already spent on materials, leaving \$143.09 remaining for this project. Still need to choose a color for Deck Over material.

**Soffet/Facia**: The budget for this project is \$490.00, material cost so far totaling \$264.95, with \$225.05 remaining for this project.

## **Pavilion:**

**Gable Ends**: This project has not been started yet. The budget for this project is \$125.00.

Ken Dugmore came up with the idea that if someone calls you to assist with a project to call someone else. 24 hours later, we had a dozen volunteers come together to help spruce up the Hammock, and to keep the guys on the special assessment assignments.
